5) ACCOMPLISHMENTS - CONNECT 2022 on September 6-8th hybrid conference was a big success. There were 8 tracks, 99 presenters and 64 breakout sessions. There 235 people registered for in-person and 76 people registered virtually. The board was really impressed with the ability to livestream the conference.

OCEAN sent out a survey earlier this year to the districts asking about whether or not we should have a conference in 2023 and how they would like to participate if we did. We heard that people prefer to meet in-person over just virtual and that it was better to hold off until spring 2024 with budget cycles. OCEAN board members will be voting on awarding the contract for the 2024 connect conference planner in a later agenda item.

OCEAN hired two contractor's Alexandria Scott and Jason Faucera. Alexandria Scott helps Jason Faucera is the OCEAN Program's Contractor he handles our website and directory maintenance as well as working with NRCS to strategize and implement our NRCS grant deliverables. Alexandria Scott is OCEAN's Administrative Support Contractor. She helps keep organizational matters up to date, takes board meeting minutes, helps develop NRCS success stories and OCEAN newsletters.

After some discussion, the board felt prepared to take a vote to award the contract. Victoria Fischella made a motion to award D Plump Consulting the CONNECT 2024 Conference Planner contract, Cathy McQueeney seconded. All approved unanimously.
- 7) CONTRACTOR UPDATES Jason Faucera was not able to attend this meeting. Alexandria Scott has been mainly focusing on completing administrative tasks as assigned by OCEAN's president and getting the spring newsletter completed. She thanked District employees for submitting content for the newsletter and encouraged increased participation in the future. There will be a summer newsletter going out in late August, Alexandria Scott will reach out to districts to see if they have anything exciting to share after the busy summer season.
